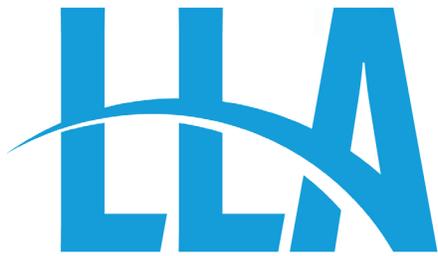

## About the Center for Local Government Excellence

The Center for Local Government Excellence began in 2015 with the proactive goal of enabling local officials and their staffs to immediately apply the knowledge and skills learned to their respective governments and use that knowledge to make a positive difference for those they serve, which will ultimately improve the services provided by local governments and the quality of local government audits.



Since 2015, 17 trainings have been offered throughout Louisiana and have been attended by more than 2,900 individuals. Topics focus on real workplace issues and provide solutions that can be evaluated and replicated. Program participants benefit not only from increasing their knowledge, skills, and abilities to enhance career development, but also from opportunities to interact with Legislative Auditor personnel and network with their peers and build a supportive environment.

## Certification

This training qualifies for a maximum of 10 hours of Continuing Professional Education (CPE) credits.
