












1		<a href="#">HCR 37</a>	Requests that the Southern University Board of Supervisors establish a mayor's institute at the Nelson Mandela College of Government and Social Sciences.
2		<a href="#">HCR 60</a>	Requests a study of the feasibility and practicality of mayor's courts.
3		<a href="#">HCR 103</a>	Requests the Department of Children and Family Services to study the feasibility of implementing a 233 helpline as an additional resource for sexual abuse victims in this state.
4		<a href="#">HR 3</a>	Provides for the continuation of the Judicial Structure Task Force as established by House Resolution No. 30 of the 2022 Regular Session.
5		<a href="#">HR 26</a>	Provides relative to use of personal electronic devices and decorum in the House Chamber and committee rooms.
6		<a href="#">HR 39</a>	Requests the state Department of Education to report to the legislature relative to adverse childhood experience education pilot programs.
7		<a href="#">HR 61</a>	Authorizes the House Committee on Ways and Means, or a subcommittee thereof, to study the state's tax structure and develop recommendations for tax system reforms.
8		<a href="#">HR 243</a>	Directs the La. State Law Institute to study provisions relative to physical or sexual abuse of a minor and consider requiring a seventy-two hour hold for offenders.

10		<a href="#">HR 267</a>	Requests state retirement systems to submit reports regarding procedures for proxy voting.

14	<span style="color: green;">Ⓢ</span>	<a href="#">HCR 38</a>	Requests the La. State Bar Association to work with organizations providing legal aid to assist parents and guardians of children with disabilities to obtain permanent tutorships.
15	<span style="color: green;">Ⓢ</span>	<a href="#">HCR 39</a>	Provides for the continuation of the Judicial Structure Task Force as established by House Resolution No. 30 of the 2022 Regular Session.

19	<span style="color: green;">Ⓢ</span>	<a href="#">HCR 68</a>	Requests that the Board of Regents and public postsecondary education management boards scrutinize the practice of hiring faculty from certain foreign adversaries.
20	<span style="color: green;">Ⓢ</span>	<a href="#">HCR 78</a>	Requests that Board of Regents and public postsecondary education management boards report to House and Senate education committees and Joint Legislative Committee on the Budget on actions related to environmental, social, and governance criteria.
21	<span style="color: green;">Ⓢ</span>	<a href="#">HCR 135</a>	Requests all state departments to identify the cost of maintaining legacy technology systems.

25		<a href="#">SR 7</a>	Urges and requests the Department of Public Safety and Corrections to provide the Senate committees on finance and judiciary C with a list of rehabilitative programs that are offered at each correctional facility.
26		<a href="#">SCR 17</a>	Requests the Louisiana Department of Health to increase eligibility requirements for the Medicaid Purchase Plan.
27		<a href="#">SCR 23</a>	To urge and request the Louisiana Department of Health to study behavioral health demand and access. 524
28		<a href="#">SCR 26</a>	Provides relative to legislative intent of certain Acts relating to causes of action for abuse of a minor.
29		<a href="#">SCR 59</a>	Requests the Louisiana Department of Health to work with stakeholders to develop a plan for the reestablishment of a nursing home following a natural disaster.
30		<a href="#">HCR 1</a>	Provides relative to the training of members of the judiciary with respect to diminution of sentence and release dates of offenders and the development of training curriculum relative to parole eligibility.
