Approval of Minutes

Senator Luneau offered a motion to approve the minutes of the March 6, 2024, meeting and, with no objection, the motion was approved.

EXTENSION REQUESTS (Audit Reports)

Ms. Allison presented 186 extension requests. This is 4% less than what we presented last July.

LEGISLATIVE AUDIT ADVISORY COUNCIL

- » Non-Emergency Extension Requests 90 days or Less. There were 123 requests. The vast majority are due to personnel and staffing issues at the agencies. We reviewed these requests and LLA recommended the committee approve. Representative Freiberg moved to grant the extensions and, with no objection, the extensions were granted.
- » Non-Emergency Extension Requests Greater Than 90 Days. We had 33 requests. One is for a fiscal year ending in 2021, 12 are for fiscal years ending 2022, and 20 are for fiscal years ending in 2023. We reviewed these requests and LLA recommended the committee approve. Representative Freiberg moved to grant the extensions and, with no objection, the extensions were granted.
- » Emergency Extension Requests Less than 90 Days. We had 1 request. We reviewed this request and LLA recommended the committee approve. Senator Luneau moved to grant the extension and, with no objection, the extension was granted.
- » Reports Received from Agencies that Requested Extensions. We had 29. This is the one for reports that were received. Because they asked for extensions and we received those reports, we recommended approval. Senator Luneau moved to grant this motion and, with no objection, the motion was approved.
- » Recommended Denial of Requested Extensions. We had eight that do not meet the criteria for approval. LLA recommended the committee approve the denial of the extension requests. Senator Luneau moved to grant this motion and, with no objection, the motion was approved.
